



Spa Party Terms and Conditions – as of February 2019

1. All parties are created for groups of a minimum of 6 children and a maximum of 20 (excluding charity events by prior arrangement)
2. All of our Spa Party Hosts have the relevant enhanced checks however we do ask that one adult remains present for the duration of the party
3. We have full Public Liability insurance (as displayed on our home page)
4. We only ever use Tropic Skincare Products during the facial element of the Silver and Gold Pamper Parties – Tropic Skincare does contain Almond Oil therefore not suitable for nut allergies

We cannot be held responsible should any allergic reaction occur from using these natural, plant based vegan child friendly products – full details are available via email hello@scrumptiousparties.co.uk

5. **Please ensure all guests are Make Up & Nail Polish** free on both hands and nails - due to skin sensitivity and fumes risk we do not carry or use nail varnish remover.
6. For safety reasons we do request all household pets be removed from the room for the duration of the party.
7. For all Spa Party bookings, we take a **NON REFUNDABLE DEPOSIT OF 50%** at the time of booking, before a booking confirmation will be made – PAYABLE BY Credit/debit card via Invoice (Unless Monthly Instalment plan has been arranged)
8. Please confirm any CHANGES to guest numbers 16 Days Prior to your event
9. The balance for all Spa Parties is due 14 days prior to the event – payable by Card/Credit Card via Invoice
10. All Parties **MUST** start at the booked party start time - we suggest the start time on invitations to be 15 minutes before your booked party start time
11. If you have chosen the Afternoon Tea Option, we will cater for most dietary requirements but cannot guarantee our Afternoon Teas will be nut free

12. Our Spa Party consent forms **MUST** be filled out for each guest prior to the Party start time - Verbal Permission to participate cannot be accepted
13. Due to previous issues guests are allowed to use mobile phones/devices to take photographs, but we discourage the use of mobile phones/devices to play music or show videos
- Our parties are designed to provide a real spa experience playing real spa music, creating a genuinely relaxing and grown up experience.
